

<p><b>In the Partisan Primary:</b></p> <ul style="list-style-type: none"><li>You may vote in only ONE party's primary.</li><li>If you choose a party, votes cast in that party will be counted. Votes cast in any other party will not be counted.</li><li>If you do not choose a party, and you vote in more than one party, no votes will be counted.</li></ul> <p><b>You must vote for individual candidates.</b></p>
