REGULATIONS GOVERNING THE INSTALLATION OF "WATER ONLY" METERS:

1. PRELIMINARY CONFERENCE: A preliminary conference with the City Administrator and/or Utility Supervisor must be held prior to submission of application to instruct the applicant on installation procedures and calculate the estimated cost of charges to be waived. No application will be considered submitted until this conference is held.
2. FEES: A non-refundable deposit in the amount of \$100.00, to cover the cost of the "water only meter," must be paid to City Hall at the time the application is submitted. An installation-inspection-administration fee of \$25.00 must also be paid to City Hall at the time the application is submitted.
3. PLUMBING: The applicant is responsible to make arrangements with licensed plumbers to make all necessary plumbing connections in advance of the meter set. Once the proper plumbing is in place, the applicant shall notify the City that the meter is ready to be set. The applicant should notify his plumber of the following specifications:
 - a. METER SIZE: 5/8" with 71/2" spread for horn or between couplers.
 - b. INSTALLATION: Contact Utility Supervisor as to what type of installation would be preferable in each circumstance.
 - c. VACUUM BREAKER: All hose bibs served by the "water only" meter must be fitted with vacuum breakers or another type of backflow preventer to insure against cross connection contamination to the water supply.
 - d. INTERCONNECTIONS: A direct line to all hose bibs must be visible, with no interconnections of any type permitted. No diversion of the water supply around the main meter is permissible, nor any type of valve system that might allow the property owner to divert water measured by the "water only" meter directly into the household.

4. WAIVER OF SEWER SERVICE CHARGES: Only the Utility Commission has the authority to waive sewer service charges on water not discharged to the sanitary sewer. The applicant is strongly encouraged not to incur any expense until the Commission reviews and approves the application. Once the “water only” meter is set, waiver of sewer service charges will begin with the next quarterly billing.

I have read and fully understand the foregoing and agree to comply with all my responsibilities under this application. I understand that any fees paid are non-refundable and that the City of Edgerton is the owner of any meter it installs. I understand that if meter failure does occur, it is my responsibility to pay another non-refundable deposit on a new meter. I further understand that this is a privilege afforded me so long as I comply with all the rules and regulations as set forth by the City of Edgerton, and my privilege may be revoked by my failure to comply with these rules.
